

Jim Inhofe—Republican. Born in Des Moines, Iowa, on November 17, 1934, Inhofe grew up in Tulsa, Oklahoma, and graduated from Tulsa's Central High School. He received a bachelor's degree in economics from the University of Tulsa in 1973, after serving in the U.S. Army from 1954 to 1956. Inhofe has been a small businessman (working in aviation, real estate, and insurance) for over thirty years. Elected to the Oklahoma House of Representatives in a special election in 1966, Inhofe was later elected to the Oklahoma Senate in 1968 and 1972. In 1978 he was elected mayor of Tulsa, winning re-election to that post in 1980 and 1982. Elected

to the U.S. Congress in 1986, he was re-elected in 1988, 1990, and 1992. Inhofe relinquished his congressional seat in 1994 to run for the U.S. Senate, and was elected to fill an unexpired term. He was re-elected to full six -year terms in 1996 and 2002. He serves on the Armed Services and the Environment and Public Works committees. Active in aviation, Inhofe became the only member of Congress to fly around the world, when he recreated Wiley Post's famous trip around the globe. Inhofe, and his wife, Kay, have been married forty-six years. They have four children and twelve grandchildren. Tom Coburn—Republican. Born on March 14, 1948, in Casper, Wyoming, Coburn was raised in Muskogee, Oklahoma, and graduated from Central High School in 1966. He received a bachelor's degree in accounting from Oklahoma State University in 1970. He worked as a manufacturing manager at the Ophthalmic Division, Coburn Optical Industries in Colonial Heights, Virginia, from 1970 to 1978. He returned to Oklahoma and entered the University of Oklahoma Medical School, where he graduated in 1983. Coburn interned in general surgery at Saint Anthony's Hospital in Oklahoma City, and completed his residency

in family practice at the University of Arkansas, Fort Smith. He returned to Muskogee, and specialized in family medicine, obstetrics, and allergy. Coburn, and his associates, serve more than 15,000 patients for whom he has personally delivered almost 4,000 babies. Coburn was elected to the U.S. House of Representatives from Oklahoma's Second Congressional District in 1994, and was re-elected in 1996 and 1998. Following his third term in the House, he returned to Oklahoma and continued his medical practice. In 2002 President George W. Bush appointed Coburn to serve as co-chair of the President's Advisory Council on HIV/AIDS. In 2004 Coburn won election to the U.S. Senate, replacing retiring Republican Don Nickles, who had served in the Senate since his election on November 4, 1980. He currently serves on the Homeland Security and Governmental Affairs, Judiciary, and Indian Affairs committees. Coburn and his wife, Carolyn, have three children and four grandchildren. John Sullivan—First District, Republican. A fourth generation Oklahoman, Sullivan was born in Tulsa, Oklahoma, on January 1, 1965. A graduate of Northeastern Oklahoma State University, Sullivan earned a bachelor's degree in business administration in 1992. Sullivan was elected and served in the Oklahoma House of Representatives from 1995 to 2002, and rose to the rank of minority whip. Sullivan was sworn in as a member of the U.S. House of Representatives on February 27, 2002, after winning a special election to fill the vacancy created by Congressman Steve Largent. He also worked as a senior aide at the Oklahoma Corporation Commission and held staff positions for former U.S. Congressman Wes Watkins. Tom Cole—Fourth District, Republican. Born on April 28, 1949, in Shreveport, Louisiana, Cole graduated from Moore High School in Moore, Oklahoma. He received a bachelor's degree from Grinnell College, a master's degree from Yale, and a doctorate degree from the University of Oklahoma. A former college professor in history and politics, Cole has been a Watson Fellow and a Fulbright Fellow at the University of London. Since 1989, Cole has been president of Cole Hargrave Snodgrass & Associates, a nationally recognized political consulting firm that has worked extensively in Oklahoma and across the nation. Cole has

worked for Ronald Reagan, George Bush, George W. Bush, J.C. Watts Jr., and other leading Republicans and conservatives. Cole has served as both chairman and executive director of the Oklahoma Republican Party, and has been called to Washington D.C., where he has been executive director of the National Republican Congressional Committee and chief of staff of the Republican National Committee. After the 2000 election, Cole was asked to serve as a member of the Bush-Cheney Transition Advisory Committee. United States District Judges

Robin J. Cauthron—Chief U.S. District Judge for the Western District of Oklahoma. Born on July 14, 1950, in Edmond, Oklahoma, Cauthron graduated from Edmond High School. She received a bachelor's degree in language arts in 1970 from the University of Oklahoma, a master's degree in education from Central State University in 1974, and a Juris Doctor degree from the University of Oklahoma in 1977. She served as the editor of the *Oklahoma Law Review* from 1975 to 1977 and was elected to the Order of the Coif. Cauthron was a teacher at Harding Middle School from 1971 to 1974, and upon graduating from law



school, became a law clerk to U.S. District Judge Ralph G. Thompson. In 1981 she and her family moved to Hugo, where she served as a staff attorney for Legal Services of Eastern Oklahoma. In February 1983 Cauthron was appointed special judge for McCurtain County, and served until October 1986, when she was sworn in as the first woman, full-time U.S. magistrate in the Tenth Circuit. In April 1991 she became the first woman U.S. district judge in Oklahoma. Cauthron is a member of the American, Oklahoma, and Oklahoma County bar associations, where she has served in several elected positions. She served as president and member of the Luther Bohanon American Inn of Court; as an officer in the National Council of U.S. Magistrates; the National Association of Women Judges; and the Federal Bar Association. She has served on the faculty of Continuing Legal Education programs, has published legal articles, and received the Maurice Merrill Golden Quill Award in 1991 for outstanding contributions to the *Oklahoma Bar Journal*. Claire V. Eagan—U.S. District Judge for the Northern District of Oklahoma. Born October 9, 1950, in Bronx, New York, Eagan graduated cum laude from Trinity College in Washington, DC in 1972. She also completed undergraduate studies at University of Fribourg, Switzerland, and graduate studies at University of Paris Institute of Comparative Law. She received her Juris Doctor degree cum laude from Fordham University School of Law in New York City, in 1976. Following law school, Eagan served as a law clerk for Chief U.S. District Judge Allen E. Born on January 22, 1940, in Beaver, Oklahoma, Leonard received a bachelor's degree in 1962 and a Juris Doctor degree in 1965, both from the University of Oklahoma. He served in the U.S. Navy from 1965 to 1968. Leonard served as an assistant to Oklahoma's attorney general from 1969 to 1971. He also was a partner in a law firm in Beaver from 1971 to 1988. From 1965 to 1968, he served on active duty in the JAG Corps of the United States Navy, attaining the rank of lieutenant commander in the Naval Reserve. He served as an assistant attorney general for Oklahoma prior to his serving as a legal advisor to Dewey Bartlett, both when Bartlett was governor and in the U.S. Senate. H. Dale Cook—U.S. Senior District Judge. Born in Guthrie, Oklahoma, on April 14, 1924, Cook graduated from Guthrie High School in 1942. In 1943 he enlisted in the U.S. Army as a private and went into the U.S. Army Air Corps attaining the rank of lieutenant. He attended Iowa Wesleyan and Central State University, and graduated from the University of Oklahoma with a bachelor's degree in 1949 and a Juris Doctor degree in 1950.
