The resurgence of interest in playing Native American stickball has kept craftsmen busy hand-making stickball equipment. Similar to a lacrosse stick, the Kabocca is carved from hickory and bent at one end to shape a cup, and then leather or deer hide thongs are used to make the pocket for catching and carrying the ball. The towa, or "ball," is crafted from cloth tightly wrapped around a small stone or piece of wood.

Public Schools In Oklahoma

Public schools in Oklahoma are operated by local boards of education, under accreditation standards established by the State Board of Education. Attendance is compulsory between the ages of five and eighteen, though schools are required to provide services for those three to twenty-one (U.S. Department of Education statistics). In addition, Oklahoma is implementing a variety of early childhood education and parental outreach programs. In most cases, the school year runs from early August to late May, although extended day and year programs are optional.

The total number of school districts in Oklahoma was 541 in 2003. The number of school districts has declined since 1914 when 5,889 school districts existed—the largest number since statehood—when schools were located within walking distance of every child. Between 1947 and 1965, almost 3,300 schools were annexed or consolidated. In 1967, 1,160 school districts operated in Oklahoma, and by 1987, that number had dropped to 615 districts. Incentives provided in 1990 fostered renewed interest in consolidation, contributing to additional reductions in the number of districts since that time.

Student Statistics

According to the State Department of Education (SDE), during the 2002–03 academic year, student enrollment (based upon average daily membership) reached 618,399, an increase of 1,567 students from the 2001–02 academic year. The 2002 enrollment figure is 3.2 percent greater than the enrollment figure ten years earlier, but is 0.9 percent lower than the high of 623,800 set in 1998–99. However, a rapid decline occurred in student enrollment from ninth grade through the twelfth grade. During the 2002–03 academic year, twelfth grade enrollment was 37, 930, compared to the ninth grade enrollment of 47,680, a notable decrease of 9,750 students. It is important to note, this dramatic decrease in enrollment between the ninth and twelfth grade is not a single year occurrence. Oklahoma school enrollment by ethnic group was Caucasian, 62 percent; American Indian, 18 percent; Black, 11 percent; Hispanic, 7 percent; and Asian, 2 percent.

During the 2002–03 academic year, 91,056 Oklahoma students qualified for the special education program, which represented 15 percent of all students. The number of gifted and talented students was 78,687, which represented 13 percent of all students in the state. A total of 323,951 (52.4 percent) students qualified for free or reduced priced meals, and increase of 19,690 students or 3.1 percent from the 2001–02 academic year. The national average of people living in poverty in 2003–03 averaged 12.3 percent, while the percentage of Oklahomans living in poverty was 13.5 percent.

According to the 2000 U.S. Census Population Report, in 1990, 74.6 percent of Oklahomans over the age of twenty-five had a high school diploma or higher, slightly less than the national average of 75.2 percent. By 2000, Oklahomans, over the age of twenty-five, with a high school diploma or higher grew to 86.1 percent, exceeding the national average of 84.1 percent. The 2003 Census estimate for Oklahomans, over the age of twenty-five, with a high school diploma or higher reached 85.7 percent, higher than the national average of 84.6 percent. In 1990, 20.3 percent of Oklahomans had a bachelor's degree or higher, and in 2000, that number had grown to 22.5 percent, but remained below the national average of 25.6 percent. The 2003 Census estimate for Oklahomans with a bachelor's degree or higher was 24.3 percent, less than the national average of 27.2 percent.

According to the 2000 Census Current Population Reports, in 1990, 74.6 percent of Oklahomans over age twenty-five had a high school diploma or higher, slightly less than the national average of 75.2 percent. Standardized Test Scores

The ACT exam is widely used in Oklahoma and other states as an assessment tool in college admissions and placement. According to the ACT, Inc. reports in 2003, 68.7 percent (24, 969) of Oklahoma's high school graduating class took the ACT. The composite score on all parts of the ACT exam for Oklahoma students was 20.7, a one-tenth of a standard score increase from 2002. The national composite score for the same year was 20.8. The Oklahoma score was slightly below the national average, but comparable to other states in the ACT's Southern region including Florida (20.5), Arkansas (20.3), Texas (20.1), Georgia (19.8), and Louisiana (19.6). In the Midwest and Southwest regions for 2003, Colorado had 20.1; Missouri, 21.4; Kansas, 21.5, and New Mexico 19.9. Oklahoma graduating seniors who took the ACT core curriculum exam scored higher (21.6) than those taking the non-core curriculum exam (18.8). The core curriculum includes four or more years of English, three or more years of mathematics including algebra, geometry, trigonometry, and calculus; three or more years of social sciences including American history, world history, American government, economics, geography, psychology, or other social science related courses, and three or more years of natural sciences including general, physical, or earth science, biology, chemistry, or physics.

The SAT is another well-recognized college entrance test, although it is not widely taken in Oklahoma. During the 2002–03 academic year, Oklahoma public school students' performance on the verbal and math components of the SAT was 569 and 562, respectively. National scores in these same areas were 507 and 519, respectively. While Oklahoma's scores were well above the national average, this performance must be placed in proper perspective. According to the College Board, the company responsible for the SAT, only 8 percent of Oklahoma's public high school graduates took the SAT in 2003. Nationally, the SAT was taken by 48 percent of public high school graduates during the same year. Most of the students who take the test in Oklahoma do so to compete for prestigious national-level scholarships or to attend out-of-state universities.

Dropout Rate

According to the U.S. Department of Education, National Center for Education Statistics, Oklahoma's single year dropout rate for grades ninth through twelfth was 5.2 percent (9,202 students), compared to the national dropout rate of 4.5 percent. Oklahoma's dropout rate was one-percentage-point higher than the median of the forty-five reporting states at 4.2 percent.

Between 1999 and 2003, an average of 25 percent of Oklahoma students between ninth grade and graduation are lost. Although some students are lost from enrollment rosters as a result of out-of-state transfers, private school transfers, incarceration, or death, the majority are student dropouts. Minority students continue to disappear from state enrollment rosters at a higher rate than white students. Oklahoma's graduation rate (from ninth grade to graduation) was 74.5 percent or 36,476 graduates for the 2002–03 academic year. The rate increased two-tenths of a percentage-point from the 2001–02 academic year and is down 2.6 percentage-points from the 1993–94 academic year. The national graduation rate for the 2001–02 academic year was 67.6 percent.

Teacher and Administrator Statistics

The Profiles 2003 State Report from the Office of Accountability reports that statewide the number of regular classroom teachers decreased by 870 FTEs for the 2002–03 academic year (37,034 in 2001–02 to 36,164 in 2002–03), with Average Daily Membership (excluding nongraded students) increasing by 1,399 students (613,705 in 2001–02 compared to 615,104 in 2002–03). Based on ADM (excluding non-graded students), the statewide student/teacher ratio for regular classroom teachers in 2002–03 was 17.0 students per teacher. The ratio is up from the 2001–02 academic year, but is still down from its high of 17.4 students per teacher in 1998–99. The average teacher salary for the 2002–03 academic year was \$34,586, an increase of \$128 from the previous average of \$34,458 in 2001–02. The percent of regular classroom teachers holding advanced degrees was 29 percent. The percentage of teachers with advanced degrees has slowly declined since 1992.

The 2002–03 academic year saw a 2.3 percent decrease in the number of administrators from the previous year. The same year, there were 3,101 administrator FTEs at the 541 districts, a decrease of 72 FTEs over the 2001–02 academic year count of 3,173 administrator FTEs. Statewide, there was an average of 5.7 administrators per school district, and each received an average salary of \$59,713 during the 2002–03 academic year, an increase of \$462, or 0.8 percent over the \$59,251 average figure in 2001–02. On average, each administrator supervised 13.0 teacher FTEs in 2002–03. The average experience that each administrator possessed in a school environment remained constant at twenty-one years.

Public School Funding

The three basic sources of school district revenue in Oklahoma are local and county, state, and federal. The largest portion of funding is provided by the state at 53.5 percent (\$2.2 billion), followed by local and county with 33.8 percent (\$1.4 billion), and federal at 12.7 percent (\$512 million). Although the 2002–03 academic year was tight economically for schools, total revenues increased by \$37,562,372, or 0.9 percent, over the 2001–02 revenues of \$3,983,060,337. However, if the federal government had not increased its education funding by almost \$200 million, Oklahoma schools would have seen a significant decrease in overall funding in 2002–03.

The revenue that schools receive from the various sources has changed considerably over the last twenty-to-thirty years. State appropriated funding has increased dramatically since the passage of House Bill 1017 in 1989–90. The situation has created an administrative paradox. While Oklahoma school districts are still controlled by their locally elected boards of education, for most districts across the state, the bulk of their funding currently comes from tax dollars appropriated by the Oklahoma Legislature. This is an important consideration, given the fact that local boards, and the communities they serve, ultimately decide whether state funds are being spent effectively within their districts.

Education expenditures are classified into eight categories: Instruction, Student Support, Instructional Support, District Administration, School Administration, District Support, Other, and Debt Service. The largest expenditure for the 2002–03 academic year was in the area of "Instruction" with 56.3 percent, a one-tenth of a percentage-point increase over 2001–02. Baring the last two years, the percentage of expenditures in "Instruction" has been on the decline since 1994–95 when it represented 58.7 percent of all funds. "District Support" was the second largest expenditure with 17.4 percent.

According to the U.S. Department of Education, Oklahoma's per pupil expenditure for 1999–2000 (the most recent year available) was \$5,770. The national average for that same year was \$7,392, meaning that Oklahoma's expenditures were nearly 22 percent below the national average. Per student expenditures varied greatly across the state. The variation is based upon the state funding formula, where rural schools receive additional funds to cover the cost required to bus students long distances and for the sparse student population. Expenditures ranged from a high of \$31,418 per student at Plainview in Cimarron County to a low of \$4,516 per student in Lone Star in Creek County.

Higher Education

According to the 2000 Census Current Population Reports, in 1990, 74.6 percent of Oklahomans over age twenty-five had a high school diploma or higher, slightly less than the national average of 75.2 percent. By 2000, Oklahomans over the age of twenty-five with a high school diploma or higher grew to 86.1, exceeding the national average of 84.1 percent. In 1990, 20.3 percent of Oklahomans had a bachelor's degree or higher, and in 2000, that number had grown to 22.5 percent, but remained below the national average of 25.6 percent. According to the US Census 2003 estimate, 24.3 percent of Oklahomans had a bachelor's degree or higher or 89.4 percent of the national total.

FY2005 Operating Budget

After a reduction of 10 percent in FY04, Oklahoma institutions have budgeted an overall increase of 3.4 percent in state appropriations support for FY05. The FY05 Education and General Budget (E&G) Part 1, which consists of public funding sources such as appropriations and student fees, shows an overall increase of 7.5 percent or \$97 million. The funding is comprised of 50.3 percent in state support and 49.7 percent in self-generated revolving funds, primarily from tuition. Because of mandatory cost increases and continuing enrollment growth, the FY05 budget must be viewed

essentially as "catch-up." Higher education institutions will once again face increases in contributions to the health insurance plans for employees and increases in risk management costs. Most institutions have made faculty and staff salary increases a priority, and a few new faculty positions have been added in order to accommodate the increased demand for course sections.

Self-generated revolving fund income increased by 12 percent, from \$621.9 million to \$696.4 million, an increase of \$74.5 million. This revolving fund increase is largely due to a 16.8 percent increase in total growth tuition and fee revenue. The increase in gross revenue generated for the system from tuition and fee revenue is \$72.8 million. The total amount of net income (less budgeted tuition waivers) generated from tuition increases and enrollment growth for FY05 is \$62.1 million. Budgeted income from state appropriations increased by \$23.1 million, from \$682.4 million to \$705.5 million (3.4 percent). State appropriations as a share of total revenue decreased from 52.3 percent to 50.3 percent. Budgeted carryover funds increased, slightly, by \$1,133,606, or 7 percent from \$16,252,948 to \$17,386,554.

Local appropriated (ad valorem tax) revenue is budgeted to increase only slightly by 0.8 percent of \$238,756. Tulsa Community College (TCC), Rose State College, and Oklahoma City Community College (OCCC) are the sole beneficiaries of this source of revenue, although it is far more significant for Tulsa Community College than the others. TCC receives \$26.8 million; OCCC, \$2.3 million; and Rose State, \$1.6 million. TCC is budgeting \$15,704 less revenue from this source, a decrease of less than 1 percent. OCCC's amount is increasing 14.3 percent, an additional \$200,000; Rose State is budgeting a 2.4 percent increase, an additional \$54,460.

Series that year, Martin batted 500 and stole 5 bases as the Cardinals defeated the Philadelphia Athletics 4 games to 3. During the series Martin was asked how he had outfielder for the St. Louis Cardinals' "Gashouse Gang" during the 1930s. In 1931 Martin batted .300 as the Cardinals won the National League pennant. In the World **Johnny Leonard Roosevelt "Pepper" Martin** (February 29, 1904–March 5, 1965), also known as the "Wild Horse of the Osage," was a third baseman and learned to run so fast; he replied "I grew up in Oklahoma, and once you start runnin' out there there ain't nothin' to stop you."
