WHEREAS, Jan Eric Cartwright served as this state's Attorney General from 1979 until 1983; and

WHEREAS, during his tenure as Attorney General, Jan Eric Cartwright courageously carried out his responsibility to uphold the provisions of the Constitution and the laws of this state; and

WHEREAS, in addition to serving as Attorney General, Jan Eric Cartwright served two terms in the Oklahoma House of Representatives, was legal counsel and legislative liaison for Governor David Boren, and served on the Corporation Commission; and

WHEREAS, Jan Eric Cartwright did not hesitate to fulfill his obligations to each public office he held, even if that meant taking an unpopular stand on an issue; and

WHEREAS, Jan Eric Cartwright was a man of principle who fought for his convictions no matter what consequences he might suffer as a result; and

WHEREAS, the integrity of Jan Eric Cartwright will long be remembered; and

WHEREAS, this state has been greatly enriched by the public service of Jan Eric Cartwright; and

WHEREAS, a fitting memorial to this great man should be established.

NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE 2ND SESSION OF THE 40TH OKLAHOMA LEGISLATURE, THE SENATE CONCURRING THEREIN:

THAT the Capitol Branch of the Oklahoma Department of Libraries, Room 109 of the State Capitol Building, be named the Jan Eric Cartwright Memorial Library.

THAT the Office of Public Affairs provide for the placement of suitable markers designating the Jan Eric Cartwright Memorial Library.

THAT copies of this resolution be dispatched to the Director of the Oklahoma Department of Libraries, the Director of Public Affairs, and the family of Jan Eric Cartwright.
