#### Introduction

One requirement of a democracy is that the public have access to government information. There are a number of libraries in Oklahoma that provide public access to the publications of federal, state, and international governments. This directory lists those libraries and provides a general guide to their collection holdings and the services that they provide. Access to the depository collections listed in this directory is, by federal and state law, open to the public. The majority of these publications can be either borrowed from the depository libraries directly, or through the interlibrary loan services that libraries provide for their patrons. These libraries also provide access to government Internet sites. This Directory is published every two years. ## Guide to Use

## This directory is divided into three sections:

**Section I.** U. S. Government Printing Office Depository Library System. The two regional depository libraries are listed first, then the selective depository libraries. The libraries are arranged alphabetically by city.

Regional depository status signifies depository libraries that receive all publications available through the Depository Library Program. Selective depository status signifies depository libraries that select U.S. Government publications in the subject areas best suited for their patrons and collection development policy. Numbers following the library name signify the unique number assigned to each depository within the depository library system and the year in which the library received its designation.

This section also includes the location of the documents within each library, the classification scheme the library uses, and other information about the collection.

**Section II.** The Oklahoma Publications Clearinghouse and libraries of the Oklahoma State Depository Library System are arranged alphabetically by city.

Section III. Special Collections are arranged alphabetically by type of collection.

#### Oklahoma Publications Clearinghouse; State Government Publications Depository Library System

Created by legislation in 1978, the Publications Clearinghouse of the Oklahoma Department of Libraries (OPC) is charged with the responsibility "...to establish an Oklahoma government publications depository library system for the use of the citizens of the State of Oklahoma; to collect state publications from every state agency and to retain and preserve permanently copies of all such publications." Publications received by the Clearinghouse from state government agencies are distributed to a network of seventeen depository libraries located throughout Oklahoma, as well as the U.S. Library of Congress.

In 1985, the Oklahoma Department of Libraries initiated a program to microfilm state government publications. This program enabled all depository libraries within the Oklahoma State Depository Library System to receive copies of all available publications that were not deposited in sufficient numbers for distribution. Currently OPC only microfiches documents for preservation and only when an electronic/print publication is not available.

In 2006, OPC started collecting digital publications from the different state agencies and digitally depositing them in a content management system. <u>Oklahoma Crossroads</u> is the Library's digital repository and is where all of the captured documents are being stored and available for public viewing. <u>Oklahoma Crossroads</u> enables the library to collect, store and provides a permanent location for viewing these documents. It also shows limited metadata for each document and is a starting point for full cataloging records.

All depository libraries provide reference assistance and participate in interlibrary loan. Requests to borrow state government publications may be made to any of these libraries or to the Oklahoma Publications Clearinghouse.
